Novo Agentic Framework vs other tools and platforms



Novo Agentic Framework

- Unlike standard conversational LLMs, **it operates as an autonomous agentic AI framework** tailored for MI team
- Writes custom code to query live APIs, orchestrates specialized "Agent Forces" for parallel research
- Enforces a strict "Zero Hallucination" mandate
- Cross-references live market scrapes to generate fully verified, enterprise-grade deliverables



Copilot

- Office Assistant
- Useful for basic tasks within the Microsoft ecosystem but it **lacks autonomous agency**
- Cannot spawn subordinate agents to conduct massive, parallel research projects



ChatGPT/ Gemini/Claude

- Conversational Brainstormers
- **"Black boxes"** that rely on pre-trained weights, making them highly prone to hallucinating



Perplexity

- AI Search Engine
- Useful for quickly finding public web links and summarizing news articles
- However, it **cannot execute complex, multi-step tasks** or write custom code to bypass API limits

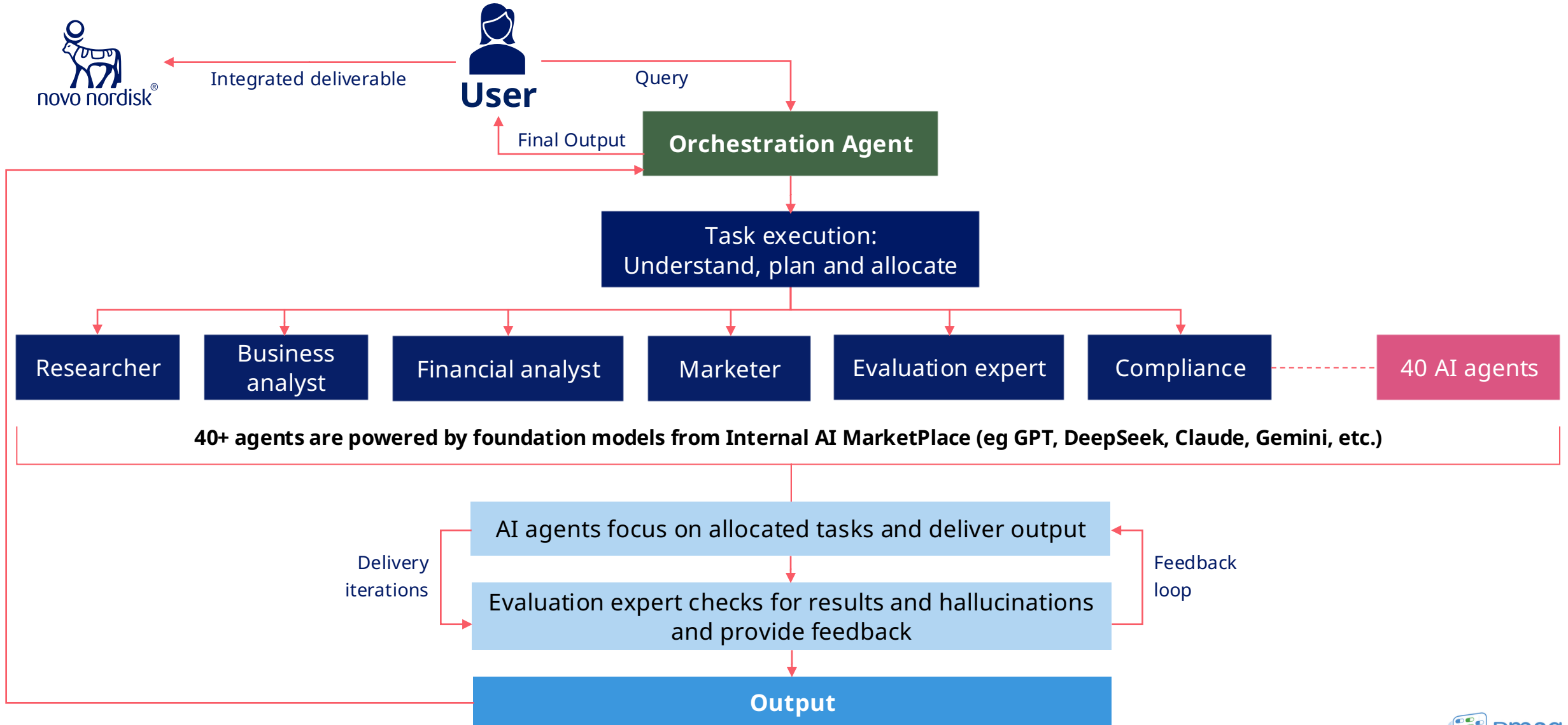
